Crown reduce by 20% and crown raise by up to 6m (above ground level) on 1 no. Horse Chestnut trees (T6 - to just below kink in main trunk) and 3 no. Sycamore trees (T5, T9 and T16). Crown reduce by 15% and crown raise by up to 6m (above ground level) on 2 no. Horse Chestnut trees (T3 - to same level as T4 pruning points; T4 - back to previous pruning points). Crown reduce by 25%, crown thin by 15% and crown lifting by up to 6m (above ground level) on 1 no. Sycamore tree (T17). Crown reduce by 25% and crown lifting up to 6m (above ground level) as one tree canopy on 2 no. Sycamore trees (T21 and T22).

All 9 trees are either within Area, A1 subject to CC/61/00162/TPO or within Woodland, W1 subject to CC/68/00163/TPO.
