T1 - To re-pollard Black Poplar tree to 0.5 - 1 metre past previous points to sound wood and balance pollard as the stems are unbalanced at present and cavities present next to previous pollard points as evidence of squirrels nesting within leaving a 6 metre x 6 metre tall tree
