Both trees are some variety of eucalyptus, and grow like crazy. I have had permission before for cutting one of them.

I want to cut them right down to a more manageable level and these trees can take it. Ive pointed them out in the photos Photos taken 10th Nov 2023 from my house)

They are in my back garden 27 Stephenson Close, West Raynham, NR21 7DH

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
