

Hedgerow Removal Notice

The hedge is now considerably overtaken by ivy and we would like to open up the view to the north from the house, across the neighbouring field. The hedge would be replaced with estate fencing, to match the estate fencing along the western boundary. I have stated that the hedge is more than 30 years old, as this is likely to be the case, but in fact I have no way of knowing. (We have been here for the last 18 years, as has the hedge.)
