T1 - Holly - Propose to monolith to 6ft to match in with the hedge due to excessive lean towards building which is within striking distance. Double stemmed tree with weak union at the base.

T2 - Thuja - Propose to remove to ground level due to root plate decay. Tree is in close proximity to property and neighbouring properties.

T3 - Portugese Laurel - Remove to ground level. Three stems with decay at base, causing damage to boundary fence and excessive shading to No42 & neighbouring property.

T4 - Thuja - Re-reduce top of the tree by 4m leaving a final height of 8m. Excessive Shading to 42 & neighbours.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
