CONDITION: The development hereby permitted shall be carried out in accordance with the drawings/documents listed under Section A above and/or such other drawings/documents as may be approved by the Local Planning Authority in writing pursuant to other conditions of this permission.

ACTION REQUIRED IN ACCORDANCE WITH A SPECIFIC TIMETABLE: AGREEMENT OF MATERIALS Prior to installation, precise details of the manufacturer and types and colours of the external cladding and finishes to be used in construction shall be submitted to and approved, in writing, by the Local Planning Authority. Such materials as may be agreed shall be those used in the development and fully applied prior to the first use/occupation.

- 4. ACTION REQUIRED IN ACCORDANCE WITH A SPECIFIC TIMETABLE: FENESTRATION
 Prior to the installation of new windows and rooflights, detailed elevation and section drawings of windows, to include vertical and horizontal sections at 1:2 or 1:5 as appropriate, shall be submitted to and

approved, in writing, by the Local Planning Authority and shall thereafter be entirely implemented as approved.

5. ACTION REQUIRED IN ACCORDANCE WITH A SPECIFIC TIMETABLE: INSULATION

Prior to installation of any insulation, manufacturer's literature shall be submitted to and approved, in writing, by the Local Planning Authority.

6. SPECIFIC RESTRICTION ON DEVELOPMENT: RAINWATER GOODS TO BE USED

Rainwater goods (including gutters, downpipes, hopperheads and soil pipes) shall be to match the existing. These shall be thereafter retained as installed.

7. SPECIFIC RESTRICTION ON DEVELOPMENT: ROOF TILES

The existing roof tiles shall be retained for reuse. If there is a shortfall of tiles, a sample of the proposed tiles shall be submitted and approved in writing by the Local Planning Authority, and the development carried out in accordance with the approved details.

8. ACTION REQUIRED IN ACCORDANCE WITH A SPECIFIC TIMETABLE: BRICK DETAILS

Prior to installation, precise details of the manufacturer and types and colours of the proposed bricks to be used in construction shall be submitted to and approved, in writing, by the Local Planning Authority. The existing bricks are to be used where required for construction, as there will be enough spare bricks from forming the new opening in the gable end.
