Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

As you look from the house to the rear of the property.

T1 Oak on the left on fence line- raise the canopy to 8.5m in height by removing the three lowest branches. 1X dead branch and 2X live branches back to the main stem.

T2 Oak stem beside shed - carefully fell in sections to near ground level. This tree is dead/dying and offers little amenity value.

T3 neighbours Oak on the right - remove the lowest branch back to the main stem. Reduce back the next branch up by up to 5m to suitable growth points to leave a finished branch length of 5-6m.

The rear garden backs onto a large mixed species woodland with premonitory oaks to the rear of this property. The work is to be carried out to allow a bit more light to the garden and give the feel of more space. when in full leaf the garden can have quite low light levels. The home owner enjoys the shade the trees provide however would like to open up a little more light to get more enjoyment from their garden. The work will have very little impact ascetically to what is visible from the street as there is a mature trees line behind.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
