Cherry, Lime & Quercus Ilex: northern aspect of courts – shape back to clear court lighting and give up to 1m clearance from external face of court fencing. To permit full potential for court flood lighting and abate a nuisance, branches contacting fencing.

 - o showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
