Important information about this consent

If you wish to change the proposed operations or their location or to carry out additional operations for which consent has not yet been given, or if a time period set out above has expired, you must give further written notice to Natural England. Before doing so, you can seek advice from Natural England.

You may face enforcement action if you carry out or permit unauthorised operations which destroy, damage or disturb the notified features of special scientific interest.

Before undertaking or permitting the operations specified in this consent, you may also need to get additional permissions from other authorities. For example, the consented operations might also require planning permission from the Local Planning Authority, a permit from the Environment Agency or a licence from the Forestry Commission. It is your responsibility, as the grantee of this consent, to ensure that no other permissions or consents, whether of a public or a private nature, are needed and, if any are needed, to acquire them before you exercise this consent.

This is Natural England's consent only, and it does not allow you to undertake or permit the specified operations without first having obtained all of the necessary permissions needed to undertake the operation lawfully. If you do not obtain all of the permissions you require, and carry out the work anyway, you may face enforcement action from other authorities or parties.

[I/We] give notice to Natural England under Section 28E(1)(a) of the Wildlife and Countryside Act 1981 (as amended and inserted by section 75 and Schedule 9 of the Countryside and Rights of Way Act 2000) of [my/our] proposal to carry out, cause or permit to be carried out the operations specified below on the land specified below.

Operation and land details

Specified operations (summary of proposal):

Installation of a mobile visitor centre unit within the existing car park area. The unit will offer sales of drinks and pre-package food, will provide a hub for community activity, and provide a focal point for information for visitors to the SPA.

Details of proposed operations:

We plan to install a mobile visitor centre at the Summer Leys section of the Upper Nene Valley Gravel Pits SSSI at Grid Ref SP 885 633.

The visitor centre will be a “loading container type unit”, raised off the ground. Once installed the centre will be 8m in length, and 4.5m in width. It includes a decking area in front which extends the total width to 6.7m. Power will come from solar panels and battery storage, with a backup generator.

Although the centre is mobile, if there is sufficient usage of the centre it will remain in position on site, and therefore planning permission will be sought from the local authority. That process will also require a flood risk assessment before permission can be granted. It is not expected that the centre will result in a significant increase in visitor numbers as numbers are currently restricted by the available parking. We do anticipate an increase in litter as a result of the supply of drinks and food. Collection arrangements will be in place alongside the centre itself, and the Trust will instigate a litter-picking arrangement in the surrounding areas of the nature reserve.

End date of proposed operations:

Due to current coronavirus related issues we are not clear on precisely when the installation will take place, but it will be completed this calendar year – before December 31st 2021. Once in place the visitor centre is anticipated to remain permanently, but may move off site if a more efficient location is available at other times of the year.


Timing of proposed operations (including avoidance of certain weather conditions):

As the works will all be taking place within the current car park footprint, we see no need to restrict the timing of the works.


Land on which operations would be carried out (include map):
