This application concerns 5 Ash trees on one private property in a conservation area. There are no TPOs on the property according to the most recent register on the tvbc site.

All the trees in this application are mature Ash. There is evidence of Ash dieback in most of the ash trees on the property, but the tree surgeon has identified 5 trees only as having Stage 3 dieback and therefore in need of immediate attention. His recommendation is that they should all be felled and everything removed from the site. The remaining affected trees may well be saveable with pruning or other measures.

The trees in question are located at the bottom of the garden behind the hedge adjacent to Wiremead Lane, and on the right hand side of the driveway, among numerous, mature trees of varied species, running from Wiremead Lane up to the house. They are marked as best as possible on the attached sketch plan. The trees bordering the driveway are adjacent to the neighbouring property Brooklands.

Crown lift the trees over the driveway to a height of 4 metres to allow access to high sided vehicles plus allow more light for ground cover.
