1. Introduction

This HRA Screening Assessment has been undertaken By Paul Hicking Associates on Behalf of Millhouse Care with regards to the proposed care home and supported living accommodation at land at Darwin Drive, Sherwood Energy Village, Ollerton, Nottinghamshire as an indication of the potential impact on the identified European Sites of Birklands and Bilhaugh and Birklands West and Ollerton Corner SSSI Ref 1/91 and the Sherwood Forest Special Protection Area (ppSPA).

The development proposals comprise of the construction of a new care home for up to 90 residents and supported living accommodation for up to 29 residents with associated hard and soft landscaping. The site is located within an area designation by the LPA for development.

The development sites at present comprises of the following habitats which were assessed using the UK Habitats Classification (ukhab, 2021):

w1g6 - native species deciduous trees

g3 - neutral grassland

g4 - modified grassland

j26 - dry ditch

This document provides a basic assessment of the potential threats upon the existing European SSSI and ppSPA habitats within close proximity of the development site using the full HRA screening assessment of January 2017 and the ecological assessment survey was undertaken in August 2023 by Paul Hicking Associates.

5 CONCLUSION

This HRA Screening Assessment has outlined the threats and pressures consistent with those identified within the 2017 LPA Screening Assessment and it is assumed that the 2017 assessment has been used when identifying land suitable for the designation of land for development including the proposed development site.

This screening assessment concludes the following;

The development is currently identified as land designated for development by the LPA.

The development site is detached from the designated sites identified within this assessment by distances greater than 1km, urban and commercial development and major road network.

The development site is currently a vacant and unused area of hardstanding and soft landscaping previously used for car parking.

The development proposes the introduction of a residential care home with supported living accommodation. Care homes are encouraged to work with the local community as a social hub to allow residents to continue hobbies and recreation.

Vehicles to and from the development is likely to be by staff, family visitors and support deliveries. The introduction of all electric vehicles will eventually further reduce the impact upon air pollution at a localised level. It is likely that an organised visit by small coach bus to Sherwood Forest may occur for some of the residents but this is likely to be infrequent.

Disease and invasive species are avoided through the introduction of new habitats which contain native species and of local provenance and which are sourced locally.
