Letter from Hampshire County Council regarding highways inspection identifying an Ash tree with large dead branches over carriageway on land belonging to the applicant. Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Hampshire County Council (HCC) have identified an Ash tree with large dead branches overhanging Blaegrove Lane which constitutes a highway hazard. Please see the location plan with the location of the tree marked with an X, also HCC's letter to Mrs Parsons with a picture on Page 3 of that letter showing the location.

The tree is on the boundary of the field adjacent to Old School House. Both the field and Old School House are owned by Mrs Pamela Parsons

Permission is sought for the removal of the dead branches overhanging Blaegrove Lane and any other part of the tree which is identified as unsafe by the company engaged to do the work. The tree is due to be inspected on Saturday 2nd December by Chris Brennan of Brennan Landscpapes.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
