## identification of free(s) and Description of works

TPO 97 is a sycamore. The tree is a mature specimen and is over 18m high, with a crown spread diameter of over 14m approx. The tree is at the front of the property located on the pavement. The canopy overhangs towards the roof of the property and neighbours garden. Proposed work would be to reduce the crown of the tree by

1-2 meters. Similar work was carried out in January 2006 based on the trees health and preservation of the cavity. The work was approved with conditions in January 2006, which was 17 years ago, the tree has grown back considerably and is now encroaching onto the properties roof and starting to block out light. The leaves that shed from the tree in autumn cause a lot of mess and block surrounding drains. With the weather changing in our climate we experience more storms, with wind and rain each year. This increases the chances of branches snapping off onto property, people and vehicles close by. If the tree was maintained any unsafe branches would be removed safely. Managing the tree regularly would benefit its health, as well as helping maintain drains and keeping property and vehicles a bit more clean and tidy surrounding three. Lots of debris falls from the tree eg bug poo, dead leaves, dead bugs and spiders which can build up in guttering and outdoor electrics ect, this cannot be stopped obviously but the amount can be helped if the tree was trimmed back a bit. The tree is not disliked in the street, but it does need some attention like it had back 17 years ago.

I applied for the tree to be cut back over a year ago and it was rejected as the arboriculturist asked for 3m to be taken off which is quite a lot. I am not wanting to pay for another report from a specialist, but that report is still available if requested.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
