T1 Horse Chestnut, crown reduce by 20% in total all around and crown lift to 5m, to allow more light in to the garden and main tree health T2 Sycamore, reduce lower canopy only back on property side by 1.5m to reduce overhang of house.

T3 Horse Chestnut, Weight reduce long limb over house by thinning 20%, crown lift to 4.5m and tip back on property side by 1m to give greater clearance from property.
