T1 - Ash tree located on property frontage between Manor Farm Barn and the Cat Protection shop, and on the conservation area boundary. To fell tree to ground level, and replant with suitable specimen.

Justification: The tree has had repeated infections of Ash Dieback and its most recent crown reduction aimed to remove deadwood and the infected material which caused a hazard to nearby busy road and footpath. It's re-infection this summer indicates the tree is in a declining state and therefore felling and replanting would not only reduce risks to nearby areas of occupation, but would provide a replacement tree to provide long term benefits.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
