T1 - Beech - Remove.

This is a potentially very large tree in a very tight spot between two houses. It is still young, but already the roots are causing considerable cracks in the concrete path.

There are concerns for the garage foundations just 1.5 m away.

And concerns for mains drainage pipes.

Two trees have been purchased as replacements.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
