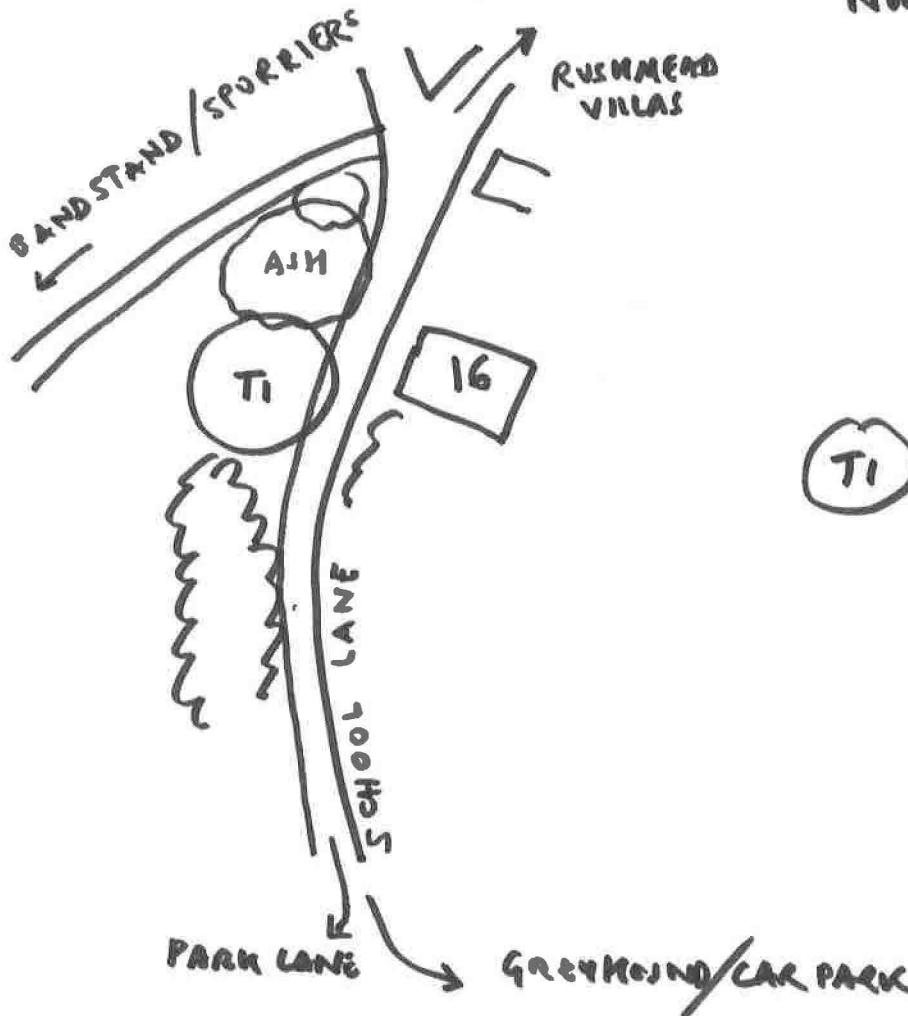
SKETCH PLAN IN SUPPORT OF
