- T1 Cotoneaster To coppice just above ground level. To manage in accordance with the space available. The tree /shrub has been left unmanaged for several years and has out grown the space, it also has a heavy lean toward the property. Coppicing would enable the new growth to be managed for better form in the future.
- T2 Holm Oak To coppice just above ground level Again this tree has outgrown the space available and is growing toward, and interfering with the property. It has grown toward the property due to suppression by T3. Coppicing of this tree and removal of T3, would allow the new growth space to develop, and therefore promote vertical growth, whilst maintaining a live root system for bank stability.
- T3 Cypress To dismantle to ground level. This tree is growing toward, and is in close proximity to the property. It is also suppressing the adjacent Holm Oak (T2). Removal will allow more light into the property and garden making a better environment for new planting in this area.
- T4, T5, T6, T7, T8. Old Sycamore pollards To coppice just above ground level These trees have been "topped" historically and are now suffering because of this previous work, they are of poor form, showing poor vitality and also have decay forming at the old pruning wounds. The idea is to coppice these trees just above ground level to encourage healthy young growth whilst maintaining the root systems to help maintain bank stability.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
