## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The trees in this application are covered by TPO Reference: HDC1068 -2001

The relevant tree numbers for this application, as per the TPO, are 13425 (Beech), 13413 (Sweet Chestnut), 13414 (Sweet Chestnut).

Tree 13425 is approximately 25m tall. Trees 13413 and 13414 are approximately 22m tall.

These are marked in the attached diagram with more accurate locations than in the TPO documentation.

Work Required for Tree 13425 is a reduction of the lower limbs over the garage by approximately three metres. Reasons: debris on property, risk of damage to property, and safety for users of the garden, in particular my one year old daughter.

Work Required for Trees 13413 and 13414 is a reduction of the crowns by approximately three metres. Reasons: Overhang nearing our property, debris onto property, and safety reasons particularly regarding dead wood.

We have been advised on the above works by an arborist who worked on several neighbouring properties, who expressed alarm at the possible safety implications of the trees and recommended we apply for works on the trees at the earliest opportunity.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
