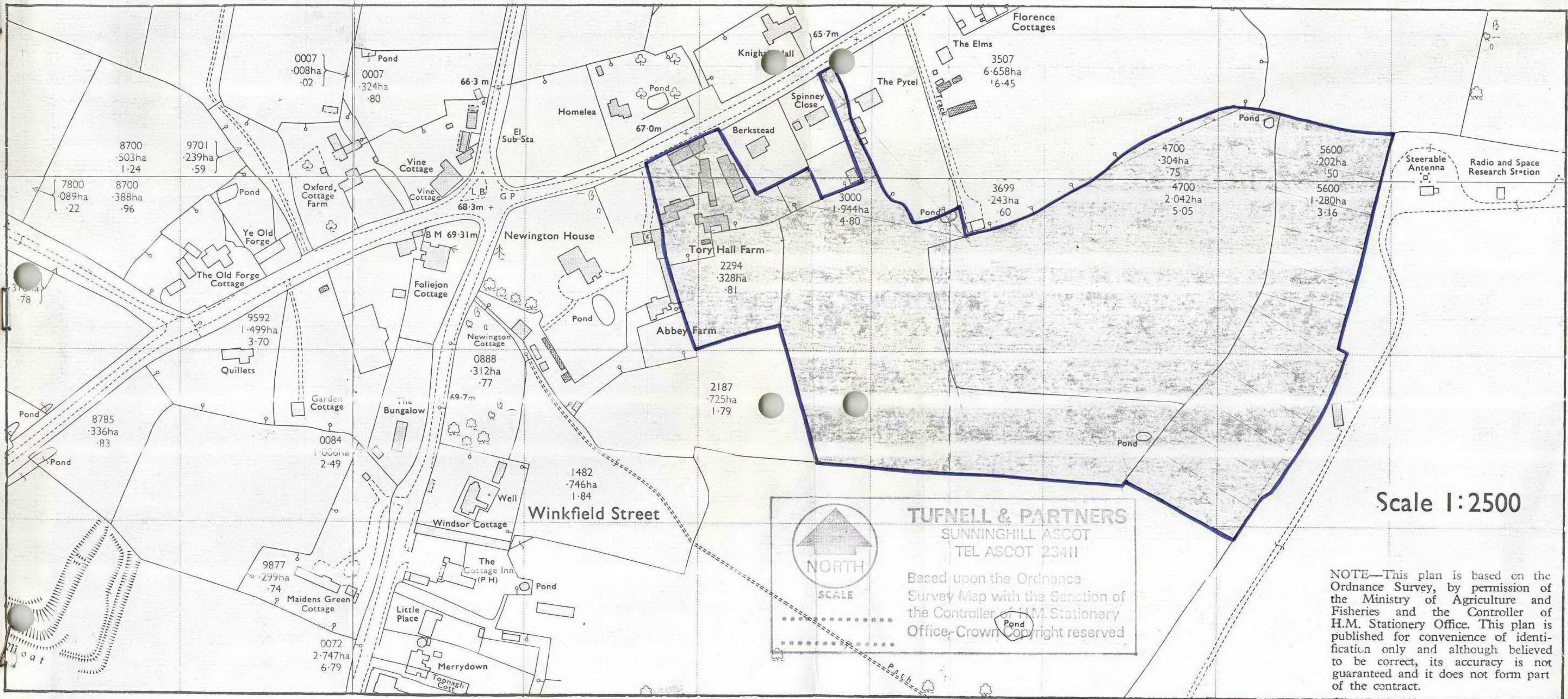

Lane aforesaid (Application No. 600677) _____

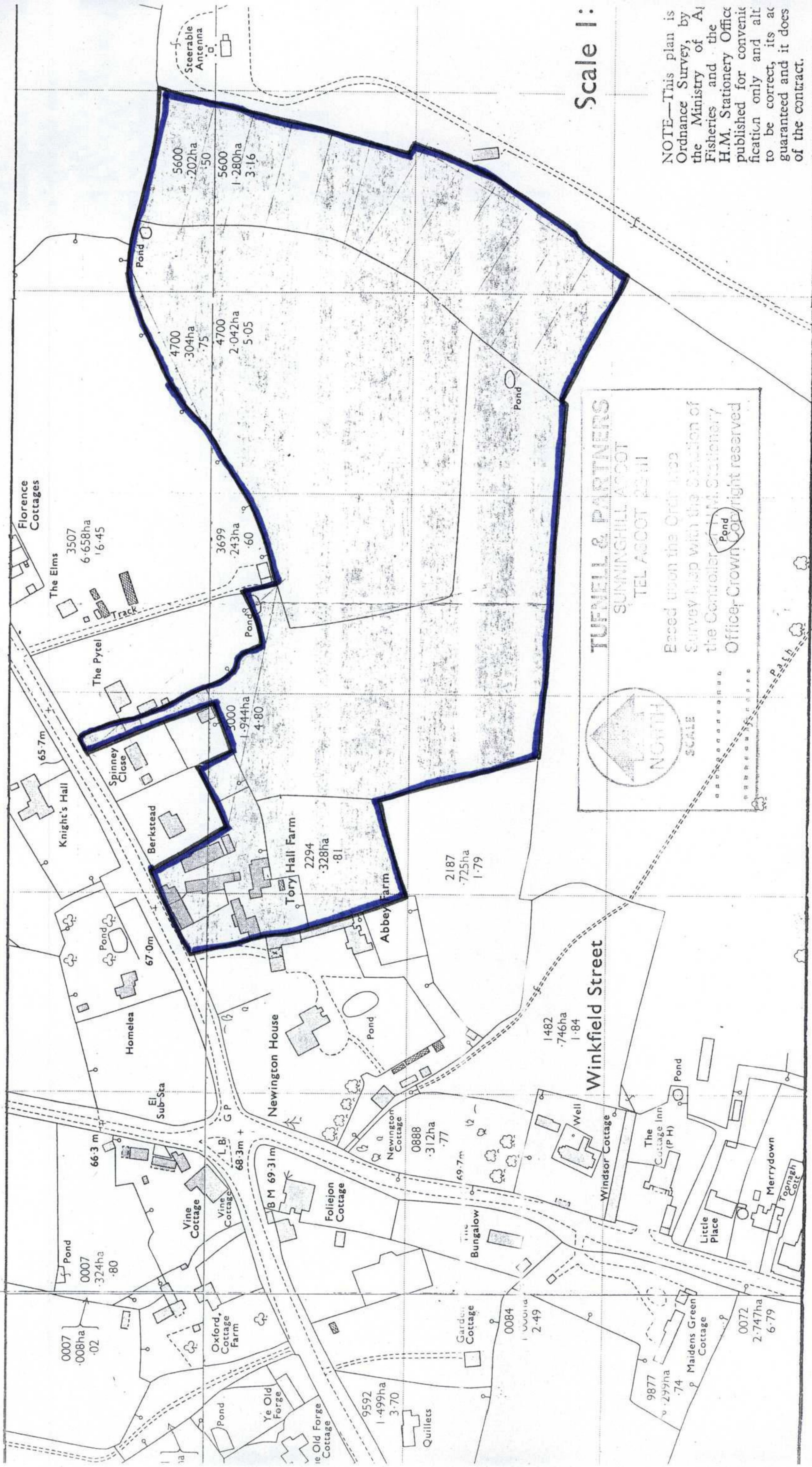
(ii) the District Council are prepared to grant plan-
