Mature Ash LHS of main driveway. This is tree is in decline due to Ash die back: therefore a heavy pollard to secondary crown break is proposed.

Fell to ground level 5 dead Ash in woodland area to the right of the main driveway .

Fell to ground level dead Ash by gravelled parking area.
