T1 Oak (Quercus) Remove major deadwood throughout whole crown area (Deadwood > 25mm in diameter). Reduce overextended limb towards house to

give approximately 2m clearance from the property. See pictures for guidance. Final height unchanged. Final spread = 10m.

T2 Golden Acacia (Robinia pseudoacacia frisia) Crown reduce by approximately 2-3m back to most recent previous reduction points, to tidy and contain.

Final height = 5m and final spread = 3m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
