T3 Sycamore x6 ,neighbours tree no 31, Growing on right hand boundary. To help improve light into garden: reduce back to previous reduction points.

T4 Ash neighbours tree no 31, Growing on right hand boundary. To help improve light into garden: reduce back to previous reduction points.

T5 Sycamore neighbours tree no 31 Growing on right hand boundary. To help improve light into garden: reduce back to previous reduction points.
