Felling and removal of 6 dead elm trees along boundary line and alongside road. See diagram and photos. These trees are now dead and are very poor in appearance. Although not tall, they do present a risk of falling on the road.

I would propose replanting with 3 beech trees or similar.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
