Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Silver birch T2 as identified on a previous application 21/1089/TPO (Betula alba pendula). This tree is a mature specimen planted in the 1960/70's (per verbal advice from Alvan Kingston your previous arborist). The tree was planted as part of a parade of birches and has grown on the eastern side of the parade. It is positioned very close to another birch in the parade on the west and has therefore grown disproportionally towards the east. The majority of the boughs and canopy are on the eastern side of the trunk. As a result the tree has developed a significant lean eastwards which is towards my property, 31 Kittiwake Drive. I believe the degree of lean has increased over the last couple of years and currently leans 25 degrees towards the house. The height of the tree exceeds the distance away from the house and therefore presents a danger of hitting the house should it fall or fail in a storm. I therefore believe the tree must be felled.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
