# WATER EFFICIENCY STATEMENT

#### 1.0 INTRODUCTION

1.1 This statement has been prepared in support of a full planning application in respect of the following:

Demolition of existing detached dwelling and outbuildings and erection of replacement dwelling and associated works.

### 2.0 PLANNING POLICY REQUIREMENTS

- 2.1 Development plan policy CS25 addresses water management and, amongst other requirements, seeks to require all new homes to limit water use to 105 litres per person per day.
- 2.2 Under policy DP11 all dwellings will be permitted only where they demonstrate delivery of the water efficiency requirement of 110 litres per person per day.

#### 3.0 BUILDING REGULATION REQUIREMENTS

- 3.1 Despite the above planning policy requirements, similar is required under the Building Regulations, specifically Requirement G2 and Regulation 36. G2 states the following:
  - G2. Reasonable provision must be made by the installation of fittings and fixed appliances that use water efficiently for the prevention of undue consumption of water.
- 3.2 Regulation 36 states the following under the heading 'water efficiency of new dwellings':
  - 36.—(1) The potential consumption of wholesome water by persons occupying a new dwelling must not exceed the requirement in paragraph (2).
  - (2) The requirement referred to in paragraph (1) is either—
    - (a) 125 litres per person per day; or
    - (b) in a case to which paragraph (3) applies, the optional requirement of 110 litres per person per day, as measured in either case in accordance with a methodology approved by the Secretary of State.
  - (3) This paragraph applies where the planning permission under which the building work is carried out—
    - (a) specifies the optional requirement in paragraph (2)(b); and
    - (b) makes it a condition that that requirement must be complied with.
  - (4) In this Part, "new dwelling" does not include a dwelling that is formed by a material change of use of a building within the meaning of regulation 5(g).
- 3.3 The above requirements will still remain relevant in full to the new build dwellings where the applicant can commit to water consumption not exceeding 110 litres per person per day.

# 4.0 WATER EFFICIENCY

4.1 For the new build dwelling, a fittings approach that is based on the water efficiency calculator methodology is to be used. The water consumption of the fittings provided will not exceed the following values:

Water fitting	Maximum consumption
WC	6/4 litres dual flush or
	4.5 litres single flush
Shower	10 l/min
Bath	185 litres
Basin taps	6 l/min
Sink taps	8 1/min
Dishwasher	1.25 l/place setting
Washing machine	8.17 l/kilogram
