The proposed installation is to be carried out by Solar Together, a group buying scheme supported and promoted by East Herts Council. The proposed supplier and installer of the panels, ENVO Energy, who won the competition by offering the lowest price, has offered the LONGI 405W Solar Panels, in black with appropriate black aluminium finish mounting kit. Eurener panels are not offered by ENVO. I am told by Solar Together representatives that the offered panels are "equivalent to" those specified by the LPA. The panels offered are of similar size and appearance to the specified panels with a similar energy output. The installation is offered to me for a discount of 36% on market costs for the same installation.
