T1-English Oak: Undertake a lateral branch reduction of no more than 1m from the tips inwards. Ensuring that no pruning wounds exceed 40mm and that all cuts are brought back to viable growth points. The above work is deemed as basic tree management and will not affect the tree physiologically or structurally. Nor will it affect the amenity value that it provide to the local treescape.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
