Beech

Proposed works to thin and reduce fragmented and overgrown crown to provide adequate clearance to property and entrance to paddock. Reduced tree size to be 8m radius and 14 m height. Advised by David Osmond - Yew Tree Landscapes

Current tree branches are hit by vehicles entering the paddock. 4.5m clearance is required and tree needs to remain balanced. Climate change also makes the tree vulnerable to damage from increased incidence of gales and wet ground as it is located in a former pond area takes a lot of water run off from the lane. Falling branches or the whole tree likely to damage the house nearby.

Please also note that T5 was felled approx 20 years ago with your permission and has been replaced by an Oak close by. Please update your plans.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
