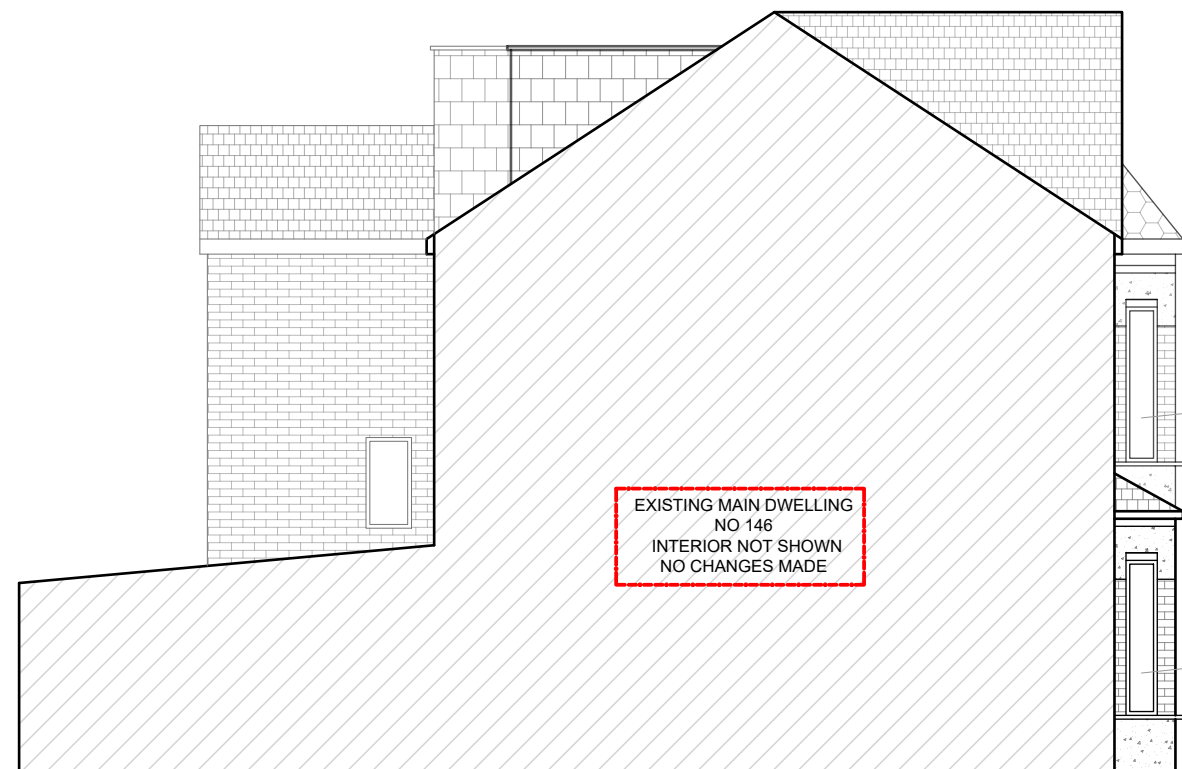

EXISTING FRONT ELEVATION



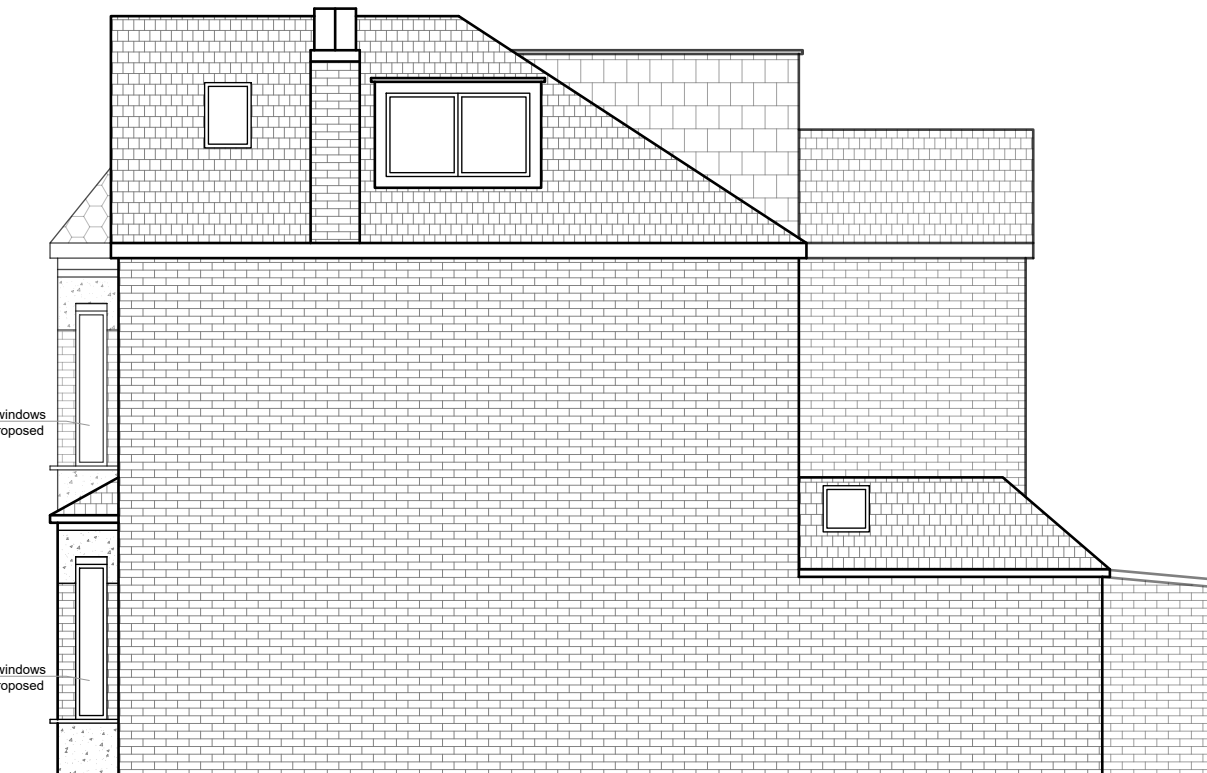
EXISTING SIDE ELEVATION

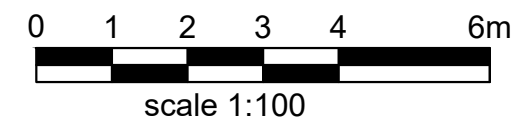
