Two holly trees in the front of Maple House (location 1 on the sketch plan) to be reduced and shaped into clearly defined cones. These trees belong to the applicant.

One holly tree in the side garden of Maple House (location 2 on the sketch plan; very close to garage and shed roofs and very close to the walls of three neighbouring premises) to be cut down as further growth is going to create problems This tree belongs to the applicant.

Yew hedge overhanging the wall in the side garden of Maple House (location 3 on the sketch plan) to be reduced and shaped. This yew hedge does not belong to the applicant. The roots of the hedge are actually located in the garden of 1 Fayre Gardens, GL7 4NU. The owner, Mrs Wendy Johnson, has had some work done on her side of the hedge, and has given us permission to do the same on our side.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
