## Identification of Tree(s) and Description of Works

The vegetation involved in indicated in the provided Arborist report - T1 T2 T3 & T4 are Oaks within the applicants land which has been incorrectly temporarily included within a neighbouring TPO which suffers from poorly defined boundaries and conflicts of information on the Local Authority website - all the above are recommended for removal

In addition C11 Wisteria is recommended for removal

The original TPO has a poorly defined border as the felt pen used has bled into areas outside of the intended area designed to protect the neighbouring copse, which also obscures the line below meant to define the TPO area, in our assessment.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
