Beech tree in the rear of 60 Tunbridge crescent on the boundary of the conservation area. The specification is to reduce in height by approximately 10 to 14 meters and reduce all lateral growth by 9 meters. This work will be pollarding the tree. The work is to condense the tree and make it as small as possible whilst maintaining the health of the tree.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
