6. Condition(s) - Removal

Please state why you wish the condition(s) to be removed or changed:

We need to amend the boundary treatments to the West of Plots 1 and 9. To plot 1, there was existing boundary wall only 700mm high, originally indicated as being took down and rebuilt with piers 1800mm high. This was taken down on-site, however, the contractor found there was no foundation. To pour a new foundation would be a considerable additional expense, which would also need to extend under the adopted footpath. To the west of plot 9, this wall was also taken down ready to be rebuilt, however, there has been a dispute with the neighbour to the south who wants the wall reinstating as existing, at circa 600mm high.

If you wish the existing condition to be changed, please state how you wish the condition to be varied:

As a result of the above. We are proposing to install a flag on edge retaining to the west of plot 1, with a 1800mm high fence over. To the west of plot 9, we propose to make good the existing 600mm high wall and install a fence over, to the overall height of 1800mm high.
