Sorbus Aria: Remove this tree which has lost branches and is now very messy and replace it with a Katsura Tree (cercidiphillum japonica) in a similar location.
Yew: remove this tree that is growing within a group comprising a conifer (chamaecyparis ~lawsoniana) and large Viburnum causing
overcrowding. Magnolia (Grandiflora): remove the half of the twin trunks that has lost the bark around the base hopefully to protect the apparently healthy other half.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
