The existing inglenook opening is too low to be usable as a cooking space. The mantel is set at approximately 1.4m above the finished floor level, and 1.3m above the modern hearth. In order to install the kitchen burner (AGA type) into the inglenook we wish to increase the usable height of the space up to 1.85m above the floor level.
