I have a very large Sycamore tree in my garden which has outgrown its surroundings. The tree now covers a large area of my front garden and now encroaches 2m into my neighbours garden. I am a 68 year old single lady and I cannot cope with the mess from the tree which stops me parking on my own drive in Spring and summer due to the honeydew sap from the tree which sticks to my shoes and ruins my carpets. The leaves from the tree block the drains in Kensington Court so my neighbours have to clear the gutters frequently in wet weather. In addition to this the tree attracts pigeons and their droppings are a disgusting mess to clean up daily in the Summer months and it really gets me down. I have made this application previously and been refused on the grounds that this tree is a visual amenity to the area - my neighbours dislike the tree as much as I do and it is now just too big for a small urban garden. I am getting older and the tree is getting larger and more unmanageable. Surely my mental and physical health are more important than a large tree which nobody wants?

If I am granted permission to fell the tree I will plant a replacement mature tree at the same time as the existing tree is removed. I shall be guided by your advice or the advice of the tree surgeon I have used regarding what would be an acceptable replacement which is visually pleasing but easier to live with.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
