## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

no1- chestnut at rear of property in lane - carry out a crown lift to 5.5 meters over highways and to lift away from property.

no2 - Chestnut along front road boundary - removal of the lowest north westerly stem over highways and reduce easterly stem by approximately 2/3 meters leaving an overall branch length of 5/6 meters.

no3 - Chestnut along front road boundary - reduce the north westerly stem over the highways by approximately 3/4 meters and crown lift 5.5 meters from ground level.

no4 - Chestnut along front road boundary - reduce the south, southwest and Northwest side by approximately 2/3 meters where needed to match canopy leaving an overall length of approximately 4/5 meters. All debris to be chipped and removed from site.

Holly hedge along front road boundary - reduce height by approximately 2 feet and trim sides hard to tidy.

2 x Siler birch along front road boundary - reduce back to past reduction points.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
