T100 - Oak - Canopy touching school building. Prune back from building to create 2m separation.

Tree Survey Report by Mark Hinsley Arboricultural Consultants Ltd. November 2023 and associated location plans.

- T101 Oak Prune out storm damaged limb.
- T102 Oak Fell, in significant decline with extensive dead areas in crown.
- T103 Oak Fell, in significant decline, with extensive dead areas in crown.
- T104 Oak Significant decay in long limb over school grounds, Prune out dead limb.
- T106 Group of trees to the rear of Dulsie Road Mixed Species Group. Young trees forming boundary screening Formatively prune to pomote growth of dense screening at low level.
- T108 Sycamore Extensive decay in several large limbs Reduce limbs containing decay and cavities.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
