The required scope of works advised previously:

Manse: There is a need to rake out and repoint the external wall elevations as necessary the four elevations. Cast iron gutter joints require re-sealing.

- Boundary / Garden Wall: There is a need to rake out and repoint the boundary wall elevation facing the footpath.

There is a need to repair mortar joints to two fallen [gate] arches, both arches are visible to the general public using or passing the church premises.

- Brick Post: There is a brick post situated in the corner formed by a 90° return of the perimeter boundary wall that has suffered some damage. The brickwork will need to be re-aligned to original.
