It is considered that the proposal to create an indoor pool extension is in principle acceptable, and its impact on the Conservation Area is minimal. While the removal of the T1 tree is likely to be acceptable the Tree Officer has concerns about the proposal on the other trees in the site and for the impact to be considered acceptable a small intrusion on the trees would be required and more favourable.
