T1 - Lime approx 28m H x 18m W

Crown reduce by 3m in height and spread resulting in overall finish height of 25m and lateral spread of 15m.

Crown thin via the removal of epicormic growth only.

Reduction to reduce overall wind loading following reports of failed branches falling on the grade 2 listed building which predates the tree.

The tree causes excessive shading in the surrounding gardens.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ~$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
