T1-Pittosporum

Ivy clad tree too close to boundary wall

Suggested works are to fell and remove stump

Previously consent was granted to remove ivy and reduce this tree, but after a more recent site visit it was decided to apply to remove it to protect the wall and allow for more light into the front that a new boundary Yew hedge can be planted

T2-Holly

Suggested works are to fell and remove stump

Tree is very close to the house and the front entrance making it very dark. There is a very large mature Apple in the centre of the front garden and the owner wishes to focus on this tree rather and make it into more of a feature.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
