When recent building work at this address was approved by Tun Wells BC, the applicant discussed with the Planning Dept, the east boundary (where it borders with the verge/pavement of Wheatfield Drive). It was apparently agreed that although the verge is owned by the LA, any maintenance to the hedge or indeed the sycamore tree (T1), which stands within it, was allowed to be carried out by the applicant Mr Garnsey. For that reason, on this F211, I've shown the owner of T1 as Mr Garnsey.

### Identification of Tree(s) and Description of Works

- T1. Sycamore. Currently 12m high with lateral spread of 6m. Propose crown reduction to 6m x 4m respectively.
- T2. Poplar. Currently 12m high with lateral spread of 8m. Proposed to pollard to 4m.
- T3. Sycamore. Current height & spread of 12m x 6m. Proposed to dismantle & remove.
- T4. Sycamore. To have an overall reduction, from current height of 12m with lat spread of 6m, to 4m & 3m respectively.
