Acacia tree in the rear garden and carpark of Redroof playschool. Reduce height by 4 metres bringing in lacteral branches of approximately 3 metres to shape. We would like to do a firm reduction on tree after concerns with its sister tree having fallen over , luckily avoiding any damage or injury, we fill a firm reduction will reduce the wind throw and safeguard the life of the tree.
