Conifer hedge (G1) - remove conifer hedging including one privet and one laurel, to create more garden space. Group of three trees (G2) - pine and two birch trees, crown lift by 2 meters over neighbour's property to allow more light to access the garden.
Laurel (T1) - reduce by 2.5 meters to a pollard at a finished height of 1.75 meters. Cherry (T2) - remove easterly limb over neighbour's property to allow more light to access the garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
