We wish to remove the tree at ground level. I think the tree is a ash. The tree is close to telephone wires and has a lot of ivy damage.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
