Acacia - reduce whole crown to previous pruning points. Approx 2-3m Failed branches have fallen, this is to alleviate failure again as tree is located very close to rear exit of property. Reduce overhang from building. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
