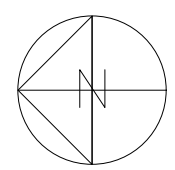
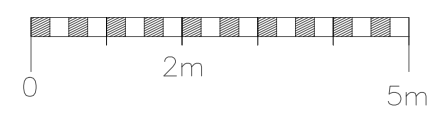


GROUND FLOOR

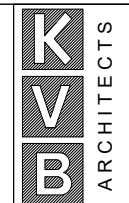
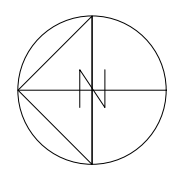
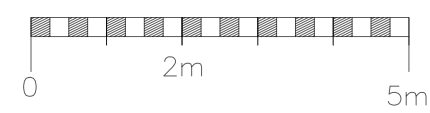


LOFT PLAN

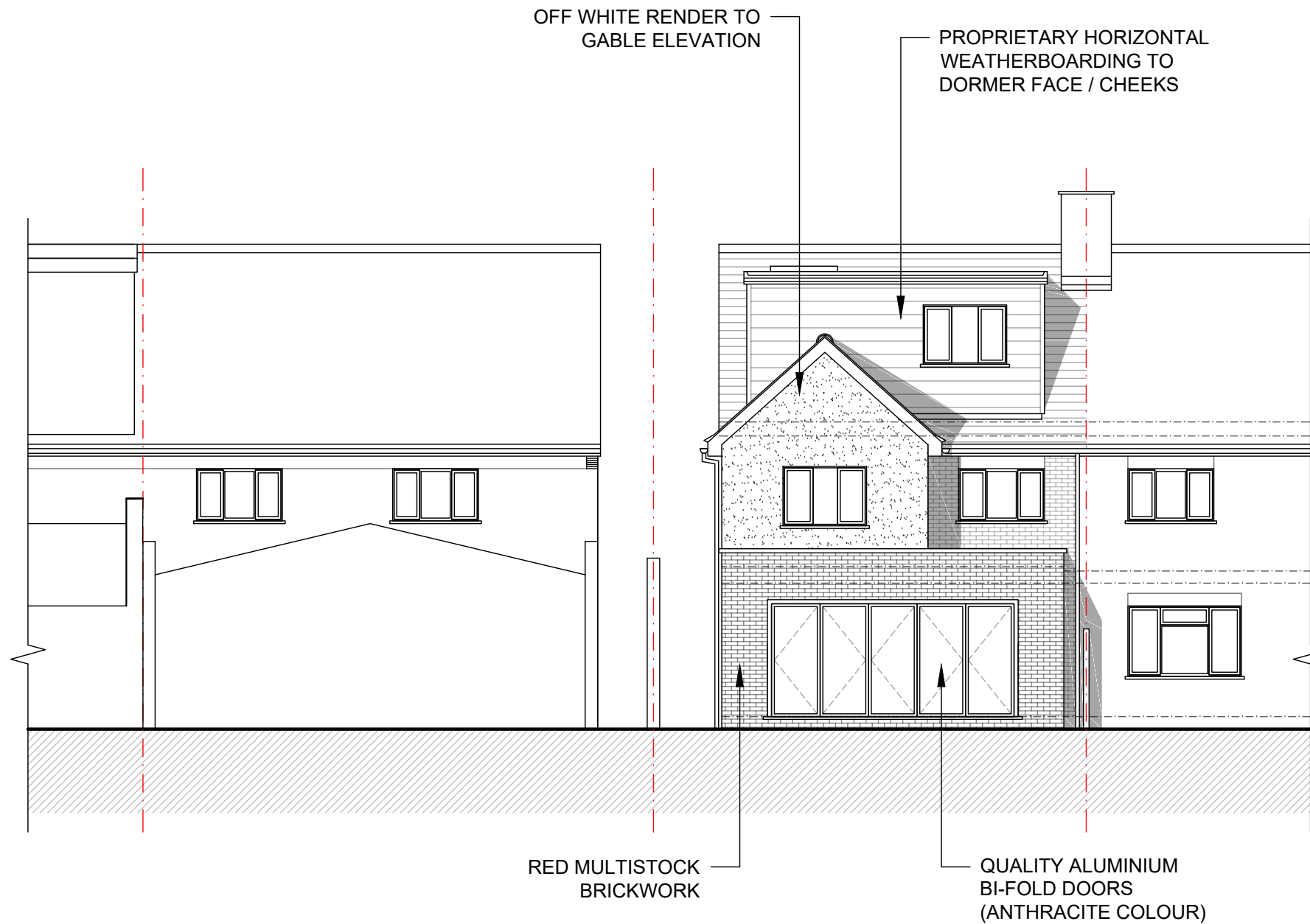


PROPOSED FRONT ELEVATION



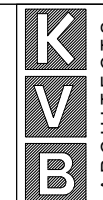
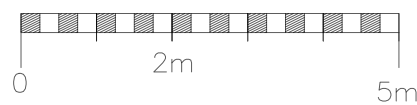

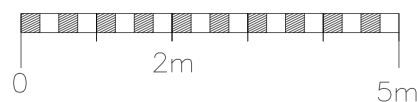


SIDE (SOUTH) ELEVATION



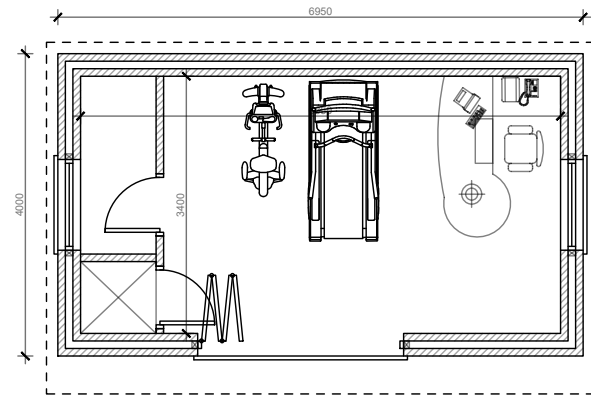

PROPOSED ELEVATION / SECTION

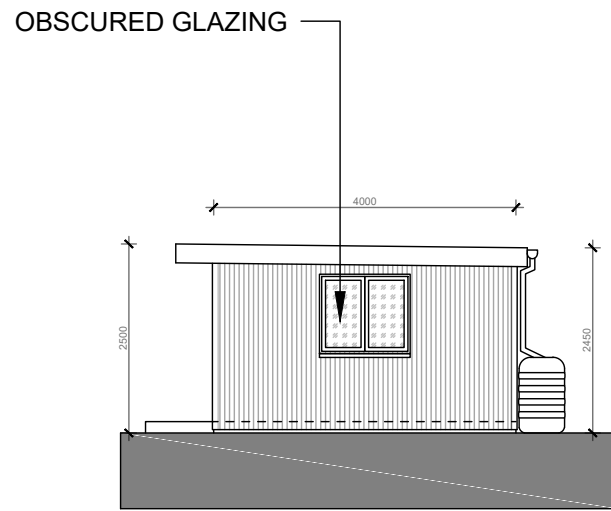

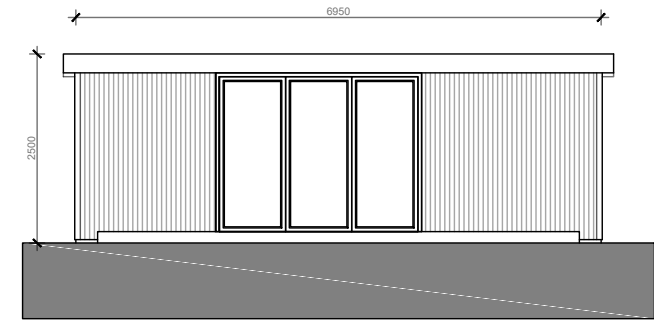

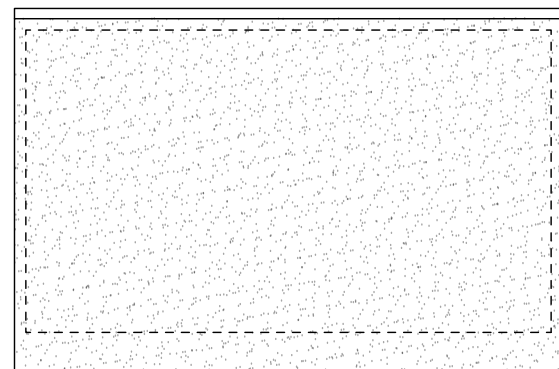
FLOOR PLAN



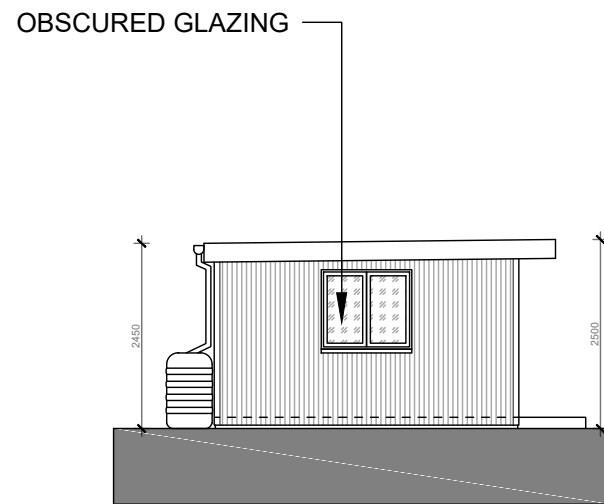
SOUTH ELEVATION



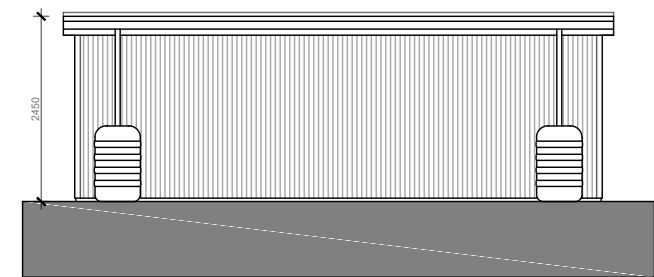
FRONT (WEST) ELEVATION

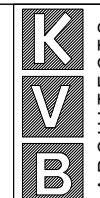
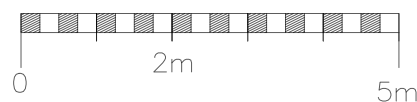


NORTH ELEVATION

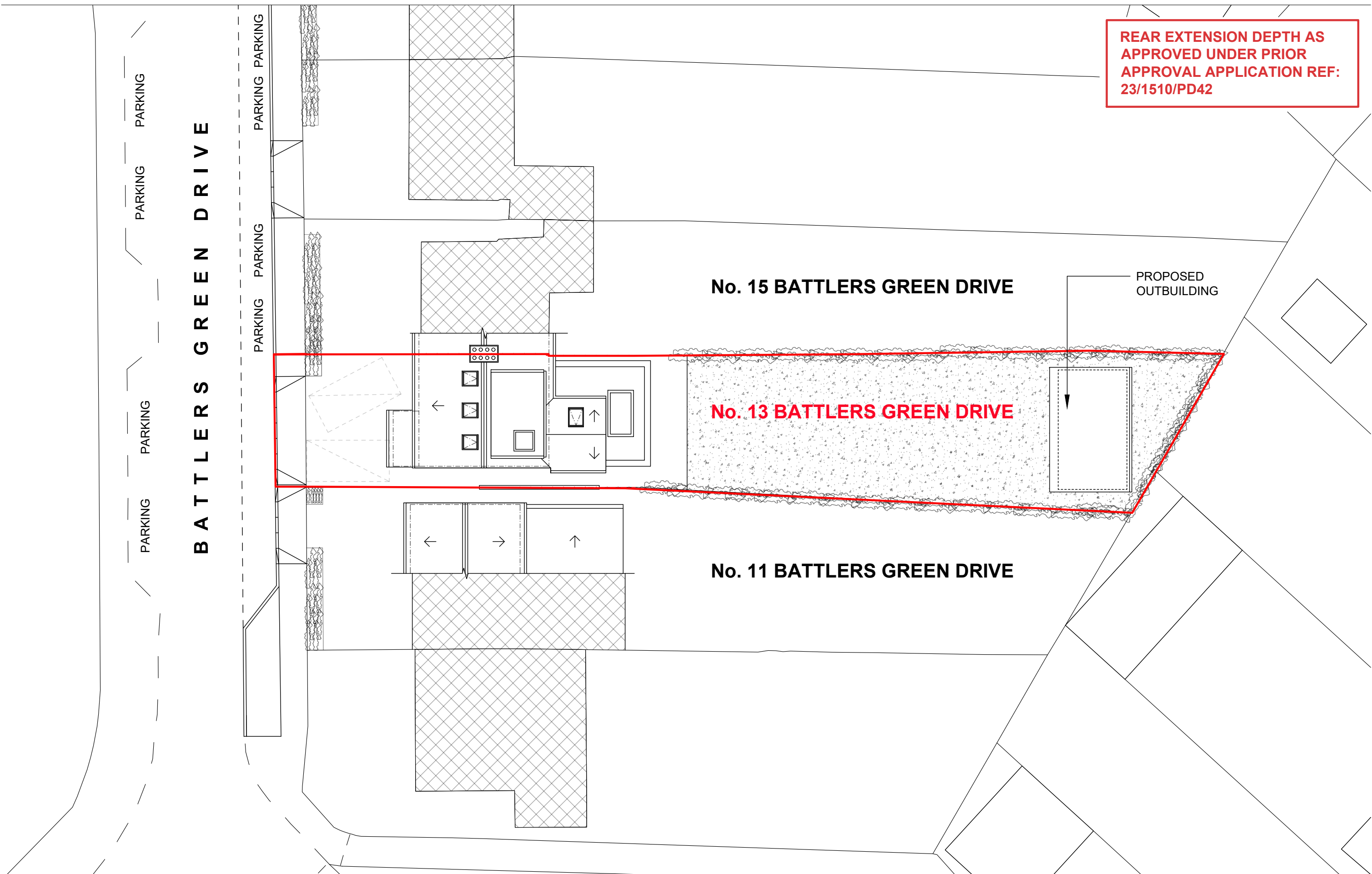

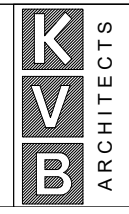
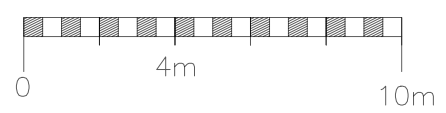
