T1 Oak believed to be within TPO 1962 NO.1 (80) - 2-3m overall crown reduction and reduce lowest limb towards the house to give a clearance of 4m to all suitable growth points.

Tree is one sided due to the adjacent multi stemmed lime, overhangs the house and home owner is concerned about it in high winds.

There are large pieces of deadwood which I will remove ASAP as I'm aware it is exempt.

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
